The Minister of the Ministry of Industry, Entrepreneurship and Trade, pursuant to Article 92 paragraph 4 and Article 93 paragraph 4 of the Constitution of the Republic of Kosovo, Articles 10, 11, and 17 of Law No. 06/L-113 On the Organization and Functioning of the State Administration and Independent Agencies (Official Gazette, No. 7/01 March 2019), Article 46, paragraph 2 and Article 47. paragraph 7 of Law No. 04/L-240 on Anti-Dumping and Countervailing Measures, as well as Article 8 paragraph 1 subparagraph 1.4 and Annex 12 of Regulation No. 02/2021 on Areas of Administrative Responsibility of the Office of the Prime Minister and Ministries takes:

DECISION
ON REPEALING THE DECISION No. 83 dated on 07.07.2016

1. Repeals the Decision No. 83 dated on 07.07.2016 for taking the anti-dumping protection measure for protection of the industry of Clay-Based construction materials from import of product/standard blocks 19x19x25 from Serbia in the Republic of Kosovo, in the amount of € 0.02 per unit.
2. This decision enters into force on the day of signature.

Reasoning

The Department of Trade based on the request of the Association of Manufacturers of Construction Materials from Clay on 16.03.2016 and the proposal of the Commission for Special Duties on Imports in accordance with the Law on Anti-Dumping and Countervailing Measures, on 07.07.2016 has issued a decision on imposing an anti-dumping protection measure in the amount of € 0,02 per unit for protection of the industry of Clay-Based construction materials from import of product/standard blocks 19x19x25 from Serbia. The anti-dumping protection measure for standard blocks 19x19x25 imported from Serbia has

arisen as a result of product sale in the Kosovo market below the normal value of the market price.

However, based on the law in force, respectively Article 46, paragraph 2 and Article 47 paragraph 7, on 07.07.2021 this measure reaches 5 years of its implementation. Therefore, the Department of Trade following the consultation with the Commission for Special Duties on Imports, and the abovementioned articles has stated that antidumping measure for standard blocks 19x19x25 imported from Serbia must be repealed, thus it has been decided as in the disposition of this decision.
