The Minister of the Ministry of Industry, Entrepreneurship and Trade, pursuant to Article 92 paragraph 4 and Article 93 paragraph 4 of the Constitution of the Republic of Kosovo, Articles 10, 11, and 17 of Law No. 06/L-113 On the Organization and Functioning of the State Administration and Independent Agencies (Official Gazette, No. 7/01 March 2019), Article 10 paragraph 1 and 51 paragraph 2 of Law No. 06/L-033 on Construction Products (Official Gazette of the Republic of Kosovo / No. 21/05 December 2018), as well as Article 8 paragraph 1 subparagraph 1.4 and Annex 12 of Regulation No. 02/2021 on Areas of Administrative Responsibility of the Office of the Prime Minister and Ministries, takes:

D E C I S I O N

1. This Decision determines the form and content of the national conformity marking for construction products used in the Republic of Kosovo.
2. The national conformity marking (K) is affixed only by the manufacturer or his authorized representative, according to the general principles for its use and the rules set out in Law No. 06/L-033 on Construction Products.
3. The form and content of the Kosovo conformity marking is defined in Annex 1 which is an integral part of this Decision.
4. The national conformity marking (K) is placed on construction products in accordance with the Law No. 06/L-033 on Construction Products and relevant sub legal acts, which require the affixing of the conformity marking for making the products available on the market.
5. Construction products which are marked with the conformity marking of other states, will be allowed to be placed on the market in the Republic of Kosovo, only when those products are marked with the conformity marking recognized by International Agreements ratified by the Republic of Kosovo.

6. The Inspectorate for Market Surveillance for construction products must ensure the correct implementation of the provisions governing the national conformity marking "K" and take appropriate action in case of improper use of the marking, including measures under Article 49 of the Law and actions for the implementation of punitive provisions according to article 56 of Law No. 06/L-033 on Construction Products.

7. This decision enters into force on the day of its publication in the Official Gazette of the Republic of Kosovo.
