Pursuant to article 18- paragraph 18.1 -sector (f), paragraph 18.5 of Law no. 2004/17 on Consumer Protection; article 2 of Administrative Instruction No. 2009/21 on Amendment and supplementation of Administrative Instruction No. 2007/05 on Label and Declaration of goods, in April 27, 2012, the Chief-Inspectorate of Market Inspection took the following:

DECISION

- I. Banned are import of products and their placement within the internal market of the Republic of Kosovo that has inscription UNMIK/Kosovo;
- II. Ban of products and placement of them within the internal market according to paragraph 1 of the present decision shall be applicable since 1st of May 2012.

Justification

Market Inspection during the inspection of domestic market has find products with label and declaration of goods that still has inscription UNMIK /KOSOVO.

The Ministry of Trade and Industry, respectively the Market Inspectorate which is in charge for enforcement of laws and bylaw acts of trade and consumer protection area, considers that such actions are in violation with the law on Consumer Protection and Administrative Instruction on label and declaration of goods, by which provision is defined marking and declaration of goods must

have the full and accurate name of importer and/ or distributor and the name of their country as well.

Therefore, since the declaration of the Republic of Kosovo state, on 17 February 2008, and the Constitution of the Republic of Kosovo have come into force on 09 April 2008, the full and correct name of our country is the Republic of Kosovo.

Considering above mentioned facts, we come to the conclusions that the specifications labeled in a product with inscription United Nation Interim Administration Mission in Kosovo (UNMIK), are in violation, first with the country's highest legal act, continuing violations with the provisions of laws and bylaws in power, wherefore, the clause has been decided through the present decision.
