The Minister of Economy, Employment, Trade, Industry, Entrepreneurship and Strategic Investments, pursuant to Article 11 of Law No. 06/L-113 on the Organization and Functioning of the State Administration and Independent Agencies, Article 8.1.4 and Annex 7, items 20, 30, 31 of the Regulation (GRK) No. 05/2020 on Areas of Administrative Responsibility of the Office of the Prime Minister and Ministries, and Decisions No. 01/07 of 11 March 2020, No. 01/09 of 13 March 2020, No. 01/10 of 14 March 2020, No. 01/11 of 15 March 2020, No. 01/15 of 23 March 2020, No. 01/16 of 26 March 2020, No. 02/17 of 27 March 2020, No. 01/18 of 27 March 2020, No. 01/22 of 5 April 2020 and No. 01/24 of 8 April 2020 of the Government of the Republic of Kosovo, based on the Law No. 2004/18 on Internal Trade, as amended by the law 04/L-005, having in mind the requirements of the National Response Plan and the recommendations of the National Institute of Public Health, in order to protect water resources and public health during pandemic of COVID-19 issues this :

ORDINANCE

on amending and supplementing the MEETIESI Ordinance No. 01/05 of 23 March 2020 on the performance of economic activities during the public health emergency

1. **Prohibits** the activity “**construction of water projects**” classified by code 42.91 in NACE rev. 2.
2. The prohibited activities include:
 - 2.1. construction of waterways, ports, river works, pleasure ports (marinas), locks in rivers and waterways etc.;
 - 2.2. construction of dams/ dikes;
 - 2.3. deviations of water flows;
 - 2.4. other constructions that have a direct impact on water and natural resources and river basins.
3. **Supplemented and amended** the Ordinance MEETIESI No. 01/05 of 23 March 2020.

4. This ordinance shall enter into force on the day of signature.
