On 11 May 2017, at the Ministry of Trade and Industry (KIESA Meeting Room), from 11:00 to 12:00 pm, KIESA's experts and its partners with whom is organized the forum will respond to your questions in regard to the organization and your participation at the Trade and Investment Forum. Companies, who need assistance on filling the application, are also advised to attend.

After the completion of the applications process review, at the Ministry of Trade and Industry (KIESA Meeting Room), will take place the interview process with the companies which have expressed their interest to participate at the Trade and Investment Forum in Zurich - Switzerland.

All expenses of the Kosovo company representatives, including transport, accommodation, food etc., will be borne by forum participants themselves.
