Pursuant to Articles 92, paragraph 92.4 and 93, paragraph 93.4 of the Constitution of the Republic of Kosovo, Articles 10 and 11 of Law No. 06/L-113 on the Organization and Functioning of the State Administration and Independent Agencies, Article 15 of Law No. 08/L-018 on Trade with Petroleum Products and Renewable Fuels, Article 4, paragraph 1.1 as well as Article 5 of the Administrative Instruction (GRK) No. 03/2022 on Price Regulation of Petroleum Products and Renewable Fuels and Other Protective Measures, Article 1 of Administrative Instruction (GRK) No. 09/2022 Amending and Supplementing the Administrative Instruction (GRK) No. 03/2022 on Price Regulation of Petroleum Products and Renewable Fuels and Other Protective Measures, Article 7 of Administrative Instruction (GRK) 03/2021 on Areas of Administrative Responsibility of the Office of the Prime Minister and Ministries, the Minister of Industry, Entrepreneurship and Trade issues the following:

DECISION

1. The following price regulation and other protective measures for oil products usable in transport are hereby set:

- 1.1. The maximum allowed wholesale trade margin shall be two (2) Euro cents per liter;
- 1.2. The maximum allowed retail price shall be twelve (12) Euro cents per liter;
- 1.3. Entities shall be obliged to supply and offer oil products for sale, as it was before setting the prices and protective measures.
- 1.4. Increased inspection supervision;
- 1.5. Expedited submission of the case to the Competition Authority, when there are suspicions of a violation of free competition;

2. Price regulation and measures from Article 1 of this Decision shall remain in force thirty (30) days from the day this Decision enters into force.

3. The Market Inspectorate, the Department of Oil Market Regulation, and other responsible bodies shall be obliged to implement this Decision.

Reasoning

The Ministry of Industry, Entrepreneurship and Trade has regularly monitored the oil products markets and based on the daily evidence received by Kosovo Customs regarding the supply/import prices of petroleum products as well as the report of the Market Inspectorate received on 10 August 2022, regarding the petroleum products retail prices, a discrepancy of local prices with large price fluctuations in the world market was evidenced, which consists a basis/reason for price regulation and the imposing other protective measures pursuant to Article 15, paragraph 2, subparagraph 2.3 of No. 08/L-018 on Trade with Petroleum Products and Renewable Fuels, Article 3, paragraph 2, subparagraph 2.3 of Administrative Instruction (GRK) No.03/2022 on Price Regulation of Petroleum Products and Renewable Fuels and Other Protective Measures.

Price regulation and other protective measures shall be set pursuant to Article 5 and Article 6 of Administrative Instruction (GRK) No. 03/2022 on Price Regulation of Petroleum Products and Renewable Fuels and Other Protective Measures as well as Article 11 of Administrative Instruction (GRK) No. 09/2022 Amending and Supplementing the Administrative Instruction (GRK) No. 03/2022 on Price Regulation of Petroleum Products and Renewable Fuels and Other Protective Measures and shall be intended to protect the consumer, protect competition and avoid the market disturbances.

The maximum allowed price and the maximum allowed Trade Margin shall be calculated for petroleum products: Diesel, Gasoline and Liquefied Petroleum Gas (LPG).

The calculation of the maximum allowed wholesale trade margin shall be made according to Article 4, paragraph 1.1 of AI No. 03/2022 on Price Regulation OF Petroleum Products and Renewable Fuels and Other Protective Measures.

The calculation of the maximum allowed retail price shall be done pursuant to Article 1, paragraph 2.1 of Administrative Instruction (GRK) No. 09/2022 Amending and Supplementing the Administrative Instruction (GRK) No. 03/2022 on Price Regulation OF Petroleum Products and Renewable Fuels and Other Protective Measures.

This Administrative Instruction shall enter into force one (1) day after its publication in the Official Gazette of the Republic of Kosovo.

In the light of the foregoing, it is decided as in the enacting clause of this Decision.
