Administrative Instruction (MIET) No. 03/2026 for the amendment and completion of the Administrative Instruction (MTI) No. 04/2019 for determining the form, content and use of the logo of the General Directorate of Accreditation of Kosovo and the Accreditation Symbol and referencing the text on Accreditation. The Minister of the Ministry of Industry, Entrepreneurship and Trade has approved it with Decision No. 01/109, Date: 20.07.2026.

Pursuant to Article 27 of Law No. 05/L-117 on Accreditation, Article 11, paragraph 1, subparagraph 1.5, Article 30 and Article 31 of Law No. 08/L-117 on the Government of the Republic of Kosovo, hereby issues:

Article 1 Purpose

The purpose of this Administrative Instruction is to amend and supplement Administrative Instruction (MIET) No. 04/2019 on determining the form, content, and usage of the Kosovo General Accreditation Directorate logo, accreditation symbol, and the text reference to accreditation.

Article 2

The text of the Annex 2 is reformulated as follows:

Annex 2: Accreditation symbol

The accreditation symbol is made up of the DAK logo, combined with:

- 2.1. The identification of the accreditation scheme and the accreditation number of the conformity assessment body for bodies accredited under an accreditation scheme.
- 2.2. The identification of the different accreditation schemes and the accreditation number of the conformity assessment body for bodies accredited under multiple accreditation schemes.

Article 3

In Annex 2 of the basic Administrative Instruction, two (2) Accreditation Symbols have been added to the Accreditation Symbol table, with the following text and appearance:

Accreditation symbol	Explanation
	Accreditation symbol for medical laboratories accredited according to SK ISO 15189. 000- Accreditation number
	Accreditation symbol for accredited certification bodies. 000- Accreditation number

Article 4

The table displaying the combined accreditation symbol in black and white has been completely removed.

Article 5

This Administrative Instruction is an integral part of Administrative Instruction (MTI) No. 04/2019 on determining the form, content, and usage of the Kosovo General Accreditation Directorate logo, accreditation symbol, and the text reference to accreditation.

Article 6 **Entry into force**

This Administrative Instruction shall enter into force seven (7) days after its publication in the Official Gazette of the Republic of Kosovo.
