**REGULATION (MIETI) No. 01/2026 ON THE APPEARANCE, SUPPLY, AND USE
OF THE UNIFORM OF THE CENTRAL INSPECTORATE OF MARKET
SURVEILLANCE**

Regulation (MINTI) No. 01 / 2026 on the Appearance, Supply, and Use of the Uniform of the Central Inspectorate of Market Surveillance was adopted by Decision No. 01/101, dated 30.06.2026

The Minister of the Ministry of Industry, Entrepreneurship and Trade,

Pursuant to Article 5 of Law No. 08/L-279 on Central Inspectorate of Market Supervision, Article 11, paragraph 1, subparagraph 1.5 of Law No. 08/L-117 on Government of the Republic of Kosovo (Official Gazette, No. 34, 18 November 2022),

Adopts:

**REGULATION (MIETI) No. 01/2026 ON THE APPEARANCE, SUPPLY, AND USE
OF THE UNIFORM OF THE CENTRAL INSPECTORATE OF MARKET
SURVEILLANCE**

**CHAPTER I
GENERAL PROVISIONS**

**Article 1
Purpose**

This Regulation shall determine the appearance, supply, and content of the uniform worn by inspectors of the Central Inspectorate of Market Surveillance.

**Article 2
Scope**

1. This Regulation shall apply to inspectors of the Central Inspectorate of Market Surveillance.
2. All inspectors of the Central Inspectorate of Market Surveillance shall wear the uniform prescribed by this Regulation during inspections.

**Article 3
Definitions**

1. Terms used in this Regulation shall have the following meanings:
 - 1.1. **Emblem** - means the graphic representation of the official identifying symbol of an institution that distinguishes it from another institution;
 - 1.2. **Uniform** - means the standardized official vest, as defined by this Regulation, which shall be worn by inspectors of the Central Inspectorate of Market Surveillance while exercising their function, duty, or service, and which serves for identification, functional distinction, and institutional representation;
2. All terms used in this Regulation shall have the same meaning as in the relevant Law on Inspections, the Law on the Central Inspectorate of Market Surveillance, and other laws in force.

3. Expressions, terms, and abbreviations used in one gender shall include the other gender, and the singular shall include the plural.

CHAPTER II

UNIFORM OF THE CENTRAL INSPECTORATE OF MARKET SURVEILLANCE

Article 4

Appearance and Content of the Uniform of the Central Inspectorate of Market Surveillance

1. The uniform of the Central Inspectorate of Market Surveillance shall consist of a vest.
2. The uniform defined in paragraph 1 of this Article shall be designed for two seasons: summer and winter.
3. The uniform of the Central Inspectorate of Market Surveillance shall be black in color, except for the emblem, which shall bear the colors of the Coat of Arms of the Republic of Kosovo, while the text placed on the uniform shall be written in white.
4. The uniform of the Central Inspectorate of Market Surveillance shall display the Coat of Arms of the Republic of Kosovo, which shall be placed on the right sleeve (appearing on the left side when viewed from the front). Beneath it shall be inscribed the text “Republic of Kosovo” and the name of the respective Ministry of Industry, Entrepreneurship and Trade. The emblem of the Central Inspectorate of Market Surveillance shall be placed on the left sleeve, with the text “Central Inspectorate of Market Surveillance” beneath it. On the back of the uniform, the acronym **C.I.M.S.** shall be displayed.

Article 5

Supply of Uniforms for the Central Inspectorate of Market Surveillance

1. Uniforms shall be supplied in a timely and regular manner, in accordance with the needs of the inspectors of the Central Inspectorate of Market Surveillance.
2. The supply of uniforms for inspectors of the Central Inspectorate of Market Surveillance shall be carried out through public procurement procedures.

Article 6

Use of the Uniform of the Central Inspectorate of Market Surveillance

1. Inspectors of the Central Inspectorate of Market Surveillance shall wear the uniform fastened, clean, and suitable for work. While wearing the uniform, the rest of the attire shall be appropriate and professional so as to represent the institution with dignity, in accordance with the legislation in force.
2. The appearance and presentation of inspectors of the Central Inspectorate of Market Surveillance while performing official duties shall reflect a professional and official image so as not to damage the image of the Central Inspectorate of Market Surveillance.

3. During inspections, inspectors of the Central Inspectorate of Market Surveillance shall also wear their identification card in a visible manner on the upper part of the uniform or hanging around the neck.

4. Male inspectors shall be prohibited from wearing visible jewelry, except for a wristwatch and one ring of normal size.

5. Female inspectors shall be prohibited from wearing visible jewelry, except for earrings, rings, a wristwatch, and a bracelet, which must be of normal size.

Article 7

Supervision

1. Supervision of the implementation of this Regulation shall be carried out by the Central Inspectorate of Market Surveillance.

2. If an inspector of the Central Inspectorate of Market Surveillance violates the provisions of this Regulation, it shall be considered a disciplinary violation and disciplinary proceedings shall be initiated against the inspector in accordance with the legislation in force.

Article 8

Repeal

Upon the entry into force of this Regulation, Regulation (MTI) No. 01/2016 on Uniforms and Their Use by Market Inspectors shall be repealed.

Article 9

Entry into Force

This Regulation shall enter into force seven (7) days after its publication in the Official Gazette of the Republic of Kosovo.
